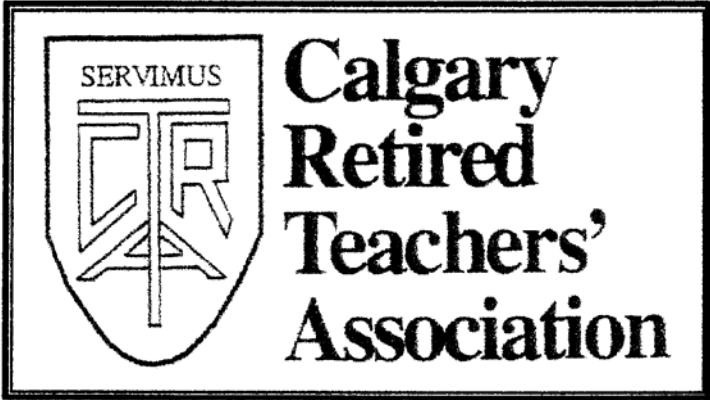
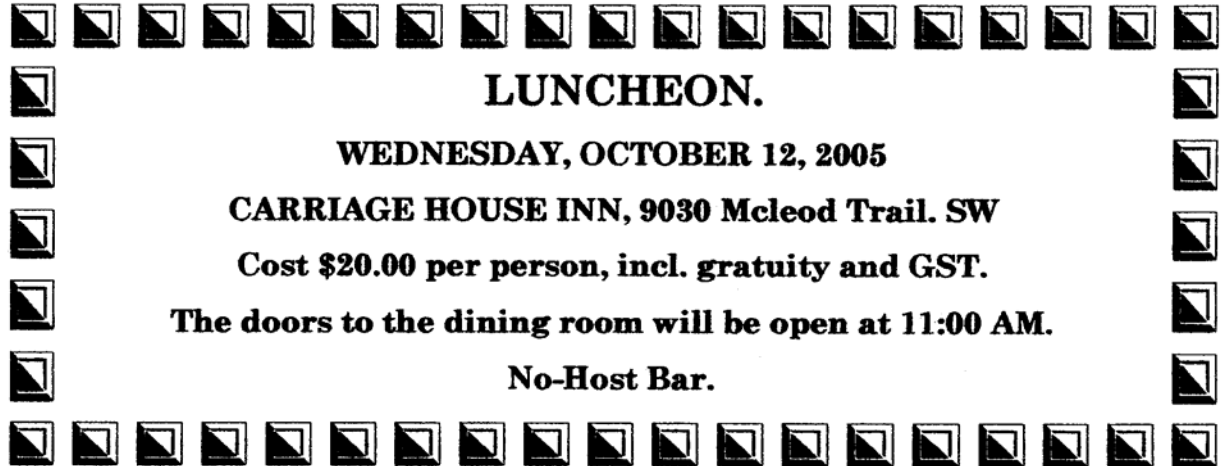

LTD MONEYS.

On Wednesday, June 29, 2005 the Honorable Justice B.E Mahoney issued a decision in the matter of steps to be taken to distribute the LTD surplus to its claimants. Justice Mahoney appointed Mr. J. Perry Dorgan of Johnson Inc (ATA) and Mr. J Allan of RSM Richter Inc (CBE) as joint trustees. Some 30+ directive regarding responsibilities, actions and timelines and costs were issued. TAX REBATE FOR SENIOR HOMEOWNERS

You might be eligible for a tax rebate from the provincial government. To qualify for this new program you must:

- be 65 years of age or older
- Be an Alberta resident
- Own residential property in Alberta
- **Have had an increase in the education portion of you 2005 property taxes when compared to the education portion of your 2004 property taxes.**

If you meet the above criteria, you may obtain an application form by calling the Alberta Seniors Information Line toll free at 1-800-642-3853.

U OF C FACULTY OF EDUCATION CELEBRATION OF 100 YEARS OF TEACHER EDUCATION IN CALGARY

The Faculty of Education at the University of Calgary has been marking its 100th birthday throughout 2005. Several events have taken place and the week-end of November 17-20 will see the most significant celebrations for teachers. The week-end events recognize that the Faculty of Education was the founding faculty of the U of C and it will trace the roots of the faculty back to the Calgary Normal School.

The whole year of celebration has been centered around the impact that teachers have had on Albertans and the province in the past 100 years. There are many activities and many different ways for teachers to participate. Over the year we have seen the launch of a virtual family tree where alumni can re-acquaint with classmates; the launch of a 200 page well illustrated book on the history of teacher education in 20th century Calgary; and commemorative displays at the Nickle Arts Museum and the Glenbow Museum Archives.
