THE PRESIDENT'S MESSAGE

Native Calgarians know very well that the long weekend in May signals the beginning of the gardening season in our part of Alberta. Add to that the warm weather we have been enjoying and you can be certain those things shared with us in the Gardening Session at the CRTA Retired Teachers' conference are already being put to good use.

With the appeal on the LTD ruling set for the fall, the next event on the CRTA calendar is the June Luncheon scheduled for the Carriage House on Wednesday, June 13.

Our luncheons continue to be successful, but pose some interesting challenges for the coming year. Consider, for example, that along with the rest of Calgary the hotel industry is experiencing a boom. Hotels can barely keep pace with the bookings and business from the corporate sector.

A few short years ago we were able to hold a luncheon for \$15.00, which included the gratuities and GST. Now, in addition to higher food and beverage costs, hotels are charging for the rental of the facilities and in an effort to attract and keep hotel staff, gratuities have risen such that 17-18% is applied to the entire bill; with the GST charge calculated on top of that.

In the past, most establishments ran their own kitchens. Now the norm seems to be to contract out the kitchens. This sometimes results in deterioration of the quality and quantity of food. We have left venues for that very reason.

Given the new parameters, it is a challenge to find a venue that can easily be accessed by all members and that can fulfill our need for a tasty, reasonably priced meal. Due to the limited number of hotels in the north-west quadrant of the city, the task is further complicated.

In view of the necessity for advanced reservations and our positive experience with the quality of food and food service at our recent conference, we have booked Dalton Center as the location for our October luncheon and Annual Meeting. The December luncheons has been booked at the Carriage House.

Early in the fall we will be requesting your assistance in completing a short luncheon survey in order to give some direction to those who plan our luncheons.

We are indebted to Irene Bruzga and Sheena Banks who have diligently worked on our behalf to ensure the success of our luncheons, complete with entertainment and door prizes.

We have also been blessed and very much appreciate the service provided by our telephone committee: Bernice Gaetz, Earl Larden, Tanis LeFroy, Julie Biggs, Mimi Hogaboam, Gloria Rasmussen, Marion Kinney, Marge Brucker, Dave Thomson and Marlene Marchand.
