## ***FROM THE PRESIDENT.***

As the 2006 calendar approaches the Ides of March, your CRTA Executive continues to work on behalf of retired teachers in the greater Calgary region.

### **Convention Get-Together**

Thank you to Shirley Holmslund for her leadership in organizing this year's Convention Get-Together at the Carriage House and thanks to the ATA Convention Committee for sponsoring the event. A delightful outlay of hors d'oeuvres, fruit and desserts set the stage for some great conversation and the special feature for the afternoon.

Dean Romfo Van Camp treated a sizable and appreciative audience to a presentation on her recent trip to the Orangutan Reserve in Borneo, one of only two areas in which the orangutan exists. Dean returned with wonderful pictures, great stories and the ability to pronounce the names of each of the orangutans. It was an amazing adventure!

### **April Luncheon**

Irene Bruzga and Gayle Fields are in the process of planning for the April 12th Luncheon at the Carriage House. They have arranged for some great entertainment and door prizes and we hope to provide the latest information on LTD and pension matters. ### **Pensions**

On March 8th, Mike Allen and Jean Crawford updated the Executive on pension matters with a summary of the ARTA presentation designed to educate retired teachers and those currently in service. Led by Mike and Jean, your pension committee awaits its second meeting with the Minister of Education and continues to work with the Alberta Retired Teachers' Association Standing Com-

mittee on Pensions, as well as Pension representatives from other Branches.

In addition to educating our own members, efforts are being made to help MLA's understand the need to address the problems with the pension plan. According to recent reports, including the May 23, 2005 ATRF document, "Funding of the Teachers' pension Plan", by the time the original unfunded liability of 6 billion is cleared in 2060, taxpayers (including teachers) will have expended a minimum of 31.4 billion to repay the 4 billion for which the government is responsible. Teachers will have paid a minimum of 15.2 billion to clear the 2 billion for which they agreed to accept responsibility in 1992. It would appear that for some reason, the government has not yet realized the magnitude of this issue.

### **LTD Fund Distribution**

As of the writing of this message, the deadline for applying to be included in the LTD distribution has come and gone. On March 9th your representatives attended a Court of Queen's Bench hearing at which the Judicial Trustees requested and were granted an extension of the above noted deadline. The Honorable Justice Mahoney extended the deadline until April 30, 2006.

In a second decision, the Honorable Justice granted the request from the judicial trustees to dispense with the final audit initially required by the court. The third request was made by RSM Richter and involves an increase to the budget submitted by the joint trustees and previously approved by the court.

Another \$75 000 is being requested, in addition to the \$510 000 already approved.

This matter will be addressed by the judge after it is reviewed by the joint trustee from Johnson Inc. and after the judge has considered that review and arguments from the different lawyers involved.

### **March 2nd Judgment**

We have also received a ruling with respect to the matter of legal costs being taken from the fund. We are not accepting of the ruling. Your representatives will gather with the ATA, ATA Legal Council and the representatives of the other beneficiary groups to consider the possibility of appeal. Further information will be forthcoming on the CRTA web site.

### **Alberta Retired Teachers' Association**

At the provincial level, Branch representatives continue to work on the new model of governance recently adopted. A retreat has been planned for mid May and will focus on the work of Board Committees and issues of concern to the fourteen Branches.

In addition to the leadership and service he provides to us as Treasurer for CRTA, Paul Demers is serving as ARTA Treasurer and will attend the retreat in that capacity. Ralph Levinson will attend as a member of the Benefits and Pension Committees. I will attend as a Consultant to the Representative Committee. Two other CRTA Executive Members will also attend. If you are interested in working with the CRTA on issues of provincial concern, please advise a member of the executive committee.

## ELIZABETH FRY SOCIETY



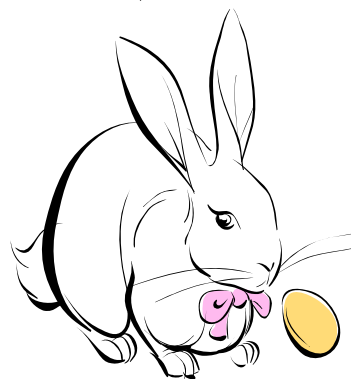
