NOTES FROM THE ARTA ANNUAL GENERAL MEETING

Seven members of CRTA's Executive attended the meeting in Edmonton on October 27th. The AGM gives the 14 branches an opportunity to be involved at the provincial level, and the delegates gain useful ideas to promote and expand the branches. Election results:

President Jack Fulwiler (Lethbridge) Vice-President Paul Boisvert (St Paul)
Past President Gordon Lowe (Lethbridge) Secretary Edwin Olsen (Rimbey)
Treasurer John Takahashi (Edmonton)

The main item of discussion was the governance model. A change to a new Governance model was debated and accepted, and the bylaws were reviewed and amended. During the coming year the Representative Committee will work on the implementation of this model, which will involve changes in the organization of the ARTA office. Mr. Sweet (who spoke to us

about this matter at the October luncheon) and Ms Billie Thompson did an excellent presentation.

CBE-LTD "SURPLUS" MONIES

The Alberta Teachers' Association, under the direction of Mr Earl Hjelter, is actively pursuing discussions with the Calgary Board of Education regarding the SunLife LTD Reserve Fund. The ATA is proposing to take a leadership role in the process of distributing funds to all eligible beneficiaries (those who paid premiums into the LTD program during the years 1981 through 1997).

At this time over 97% of all employee-group beneficiaries have formally endorsed the ATA proposal. It is anticipated that this will speed up the collection and distribution process.

Gordon Branson has agreed to allow his name to stand as nominee for the position of Judicial Trustee. If real progress is made, more information will be presented at the December luncheon.

CRTA AD HOC COMMITTEE ON PENSIONS AND PENSION ISSUES

TAKE A MOMENT TO REMEMBER THOSE OF OUR COLLEAGUES WHO HAVE PASSED AWAY

Beattie, Catherine Elizabeth (known to her friends as "Cate") - died in a tragic accident near Perth, Australia on October 3. Cate had taught in several different schools in Calgary for 20 years before moving to Australia in 2000. She is remembered by colleagues as a "vibrant, energetic person who really cared about kids".

Erickson, Evelyn Margaret - was born on March 13, 1920 in Saskatoon, SK. She received her teaching Certificate from Calgary Normal School and continued her education for many years after. In 1971 she graduated with a B Ed from the University of Calgary. Evelyn served as principal for many years at various Calgary Catholic schools.

Forbes, Elizabeth (Beth) Frances - passed away November 3 at the age of

92. She was born in Medicine Hat in 1912. Beth enjoyed a long career as a teacher and principal. Her love of children was evident in all that she did for them.

Hausdorf, Mary Elizabeth (nee Strban) - passed away in Canmore on October 10. She was born in 1910. Mary Elizabeth was one of the first graduates of the Canmore High School and went on to study at the Calgary Normal school. She taught at a number of rural Alberta schools.

Huck, Esther - Esther was born in Luseland, SK. She began her teaching career in 1964. After the completion of a B Ed at the University of Calgary in 1972, she continued working as a teacher, Vice Principal and Principal and Language Arts Consultant. She retired in 1980.

Lamb, Ivy - Ivy was born on May 21, 1917. She was a graduate of the Moose Jaw Normal School. Before her marriage she taught at a number of small schools in rural Saskatchewan. Because of a teacher shortage, Ivy resumed her career in public education in 1948. She then mostly taught Kindergarten and the primary grades. She retired from education in 1974 as Vice-Principal in Bready, Saskatchewan.

Martin, Victoria Anastasia - Victoria passed away on October 20, 2004 at the age of 90. She was born in Langdon, AB and was a graduate of the Calgary Normal School. She began teaching in the Rosebud and Mosleigh area of Alberta. After a period of time in British Columbia, Victoria returned to Calgary, where she finished her career as Assistant-Principal and Principal. Victoria retired in the early 1970's.

Matheson, Bill - passed away on November 10 in Salmon Arm, BC. Bill was raised in Calgary, where he went to Normal School. He then earned his M Ed at the University of Alberta. Before his retirement in 1976, Bill had a long career as a teacher and a principal in a number of Calgary schools.

Norris, Christina Margaret - passed away on October 7 at the age of 88. Margaret was born in Calgary and was a long-time teacher, starting in one-room schools in Oyen and De Winton and then teaching Kindergarten at an elementary school in Okotoks.

Notermans, Gerard - passed away on November 12. Gerard was born in the Netherlands and came to Canada in 1975. He taught at William Aberhart and Lord Beaverbrook High Schools until his retirement in 1990. Gerard was a church choir director and a member of the Calgary Philharmonic Orchestra Chorus for 22 years.

Popiel, Iris Gloria (nee Kostiuk) - Iris was born on July 19, 1942 and passed away on September 18. She obtained her Bachelor of Education degree from the University in Saskatoon. Iris enjoyed a short career in teaching in Lethbridge before her marriage.

Ross, Tim also known as "Shader" - died in a climbing accident in Scotland. Tim graduated with a B Ed from the University of Calgary and was a leader in Outdoor Education. He taught many Calgary students at the University of Calgary Outdoor Center in Kananaskis and Camp Chief Hector at Seebe.

Taylor, Mildred (nee Metheral) - passed away on November 3 at the age of 85. Mildred was an Elementary school teacher in Calgary for 20 years. She had a lasting effect on her students, many of whom continued to write to her long after her retirement.
